Please remember if you are going to make any modification to your unit that can be seen from the outside, affects a load-bearing wall, affects the shared utilities, or affects Association property, i.e. satellite antennas, windows, doors, etc., you must fill out an Architectural Application *PRIOR* to the work being done.

You can download an Architectural Application from the Documents page on the CDA website. You will also need to provide proof of Owner's liability insurance with the application. And, if you are using a contractor, they will need to provide proof of liability insurance as well.
